

Privacy Policy

The Privacy Policy is aimed at describing the management of personal data collected by FCA Security S.c.p.A. ("Company") through this website, in accordance with applicable law.

COLLECTION OF PERSONAL DATA

The personal data that may be collected are the following:

- a. personal data provided to receive a specific service (e.g. name and contact details);
- b. navigation data (e.g. IP address, location - country -, information on the pages visited by the user within the website, access time on the website, navigation time on each page, clickstream analysis. Although the Company does not collect this information to associate it with specific users, you can identify those users directly from that information or using other information collected);
- c. cookies (i.e. small text files that can be sent and recorded on the user's computer by the websites visited, to then be re-transmitted to the same websites when the user visits them again. For further details, please refer to the Cookie Policy present on the website).

PURPOSE AND METHODS OF TREATMENT

The personal data collected ("Data") may be processed for the following purposes:

- a. execute a specific user request or provide the requested service ("Service");
- b. improve the user experience on the Company's websites.

The Data may be processed using paper, automated or electronic methods.

OTHER PARTIES WHO MAY PROCESS THE DATA

The Data may be processed by subjects operating on behalf of the Company and by virtue of specific constraints contracts, in EU or non-EU member countries.

The Data may be disclosed to third parties to fulfill legal obligations, to comply with orders from public authorities or to exercise a right of the Company in court.

DATA TRANSFER OUTSIDE THE EUROPEAN ECONOMIC AREA (EEA)

The Company declines all responsibility regarding requests and/or supply of personal data to third-party websites.

OWNER OF THE TREATMENT

The data controller is FCA Security S.c.p.A.

DATA RETENTION

The Data processed to provide the Service will be kept by the Company for the period deemed strictly necessary to achieve these purposes. However, the Company may continue to keep such Data for a longer period, in order to be able to manage any disputes related to the provision of the Service.

Data processed to improve the user experience on websites will be kept for the periods indicated in the Cookie Policy.

THE RIGHTS OF THE INTERESTED PARTY

The interested party has the following rights:

- a. right of access, i.e. the right to obtain confirmation from the Company as to whether or not the processing of data and, in this case, to obtain access to it;
- b. right of rectification and cancellation, i.e. the right to obtain the rectification of inaccurate data and/or the integration of incomplete Data or the cancellation of Data for legitimate reasons;
- c. Right to restriction of processing, namely the right to request the suspension of processing if legitimate reasons exist;

- d. Right to restriction of processing, namely the right to request the suspension of processing if legitimate reasons exist;

- f. Right of objection, namely the right to object to data processing if legitimate reasons exist;
- g. Right to address the competent data protection authority in case of unlawful data processing.
